#### TREASURER'S REPORT

President Jeff Elsing thanked Councilmembers Aurelle Genzlinger, Ric Asplundh, Brent McCurdy and Glenn Gurney for filing election petitions to serve another term on Borough Council.

# **POLICE CHIEF'S REPORT**

On Friday February 8<sup>th</sup> at 4:08pm, police assisted the Bryn Athyn Fire Company at the new student union center construction site at 900 Campus Drive for a report of a heater that was on fire. The Fire Company was able to shut off the gas and extinguished the fire.

On Saturday February 9<sup>th</sup> at 10:22am, police conducted a vehicle stop at Huntingdon Pike and Cathedral Road which resulted in the arrest of a 52-year-old male resident of Elkins Park on an active warrant for theft in another jurisdiction. The subject was turned over to the Montgomery County Sheriff's Department.

During the month of February, our officers continued to conduct proactive patrols, which led to five vehicles being towed for the month. This brings the total to ten vehicles that have been removed from the Borough streets in the first two months of the year for various reasons, including vehicles that were being driven by unlicensed drivers, vehicles driven without valid insurance, valid inspection and/or vehicles being driven by drivers with a suspended driver's license. Removing such vehicles are helping to make the Borough streets much safer and I commend our Officers for always being vigilant while on patrol.

The Borough saw a significant reduction in traffic congestion since Philmont Avenue reopened in February after being closed for construction since June of 2018.

Officer Kevin Green completed a three-day SFST (Standardized Field Sobriety Testing) school in February, which included training on HGN (Horizontal Gaze Nystagmus) evaluation. This is a specialized school that all of our other officers have previously attended.

### FIRE CHIEF'S REPORT

26 Fire Calls, 3 in Bryn Athyn were reported for February; 102 EMS Calls, 12 in Bryn Athyn, with 72 transports, 8 of those in Bryn Athyn.

### **BOROUGH MANAGER'S REPORT**

## Byberry Road Bridge

Vikki Trost spoke with the local Penn DOT representative for the Byberry Road Stone Arch Bridge Rehabilitation project regarding the schedule for the bridge work. The work was scheduled for early 2019 however other urgent bridge repairs have bumped this project to later in the schedule. We expect to have more information next month when the construction schedule is updated.

Questions were raised about the upcoming Red Lion Road bridge construction work in Lower Moreland Township.

# Aqua Pa Water Main Project

Last month Council asked Vikki Trost to contact Lower Moreland to find out how to get money to restore roads after the Aqua PA water main replacement project on Fetters Mill Road between Alden and Hallowell Roads.

Steve Woerner informed Vikki Trost that the utility is required to restore roads (mill and pave half-width) in Lower Moreland by ordinance. He noted that Aqua PA seems to do this everywhere anyway. Steve said that when Aqua PA finishes a project, the offer a monetary payment in place of paving the half width. This payment actually pays for about two-thirds of the entire road paving using the contracted price each year, so they are able to pave more. Since this new Aqua PA project on Fetters Mill Road also extends into Lower Moreland, Steve recommended that we let Aqua PA pave half the width, since that road was paved more recently.

#### **PUBLIC SAFETY COMMITTEE**

Chairman Jeff Elsing reported that he received a letter from the police officer contract negotiation team to open negotiations for a new employment contract for 2020-2021-2022. The Borough Committee for Police Contract Negotiations will include Jeff Elsing, Duane Hyatt and Drew Nehlig.

Mr. Elsing reported that the July 4<sup>th</sup> Fireworks proposal is \$1,000 higher this year. Mayor Schauder reminded Council of the fireworks every other year discussion. Mr. Elsing plans to go ahead with fireworks this year, to which Council agreed. Businesses along Huntingdon Pike will be solicited for donations.

## PUBLIC WORKS COMMITTEE

Chairman Mark Pennink reported that Borough Engineer, Nick Rose, is working on the plans for Alden Road and Tomlinson Road.

There were 2-3 snow/ice events last month which mainly required salting.

Mr. Pennink has been in contact with Steve Woerner at Lower Moreland Township with regard to 2019 paving. Mr. Pennink is looking to pave King Road and Sycamore Road and the bottom of Alden Road near 2500 Alden. He also plans to continue the five-foot patching along Buck Road.

Mr. Pennink stated that he will need funds for Alden Road at Fetters Mill Road drainage work. There have been no recent complaints from the homeowner dealing with the underground spring. There has been a great deal of water freezing on Alden Road down to Fetters Mill Road this winter.

#### FINANCE COMMITTEE

Chairman Duane Hyatt reported that the Committee discussed the status of the Portnoff collections accounts. We will be filing with Portnoff for current delinquent accounts. Mr. Hyatt explained that it is not fair to residents who pay their bills to not file for these funds.

The Committee discussed increasing the Borough's MasterCard limit for the Sewer Department from \$2,000. The Committee recommended increasing the limit from \$2,000 to \$2,500. Council had no objections.

Mr. Hyatt reported that the Sewage Treatment Plant Equalization Project is well on the way to completion and looks to be under budget.

The Finance Committee recommends that Borough Council approve the transfer of the 2018 budget allocation for Police Car Reserve to the Police Car Reserve Account. After the completion of the 2018 Annual Audit, the Finance Committee recommends that the remaining surplus, not to exceed \$200,000 be transferred to the Public Works Reserve Account.

On a motion by Aurelle Genzlinger, seconded by Brent McCurdy, Council voted unanimously in favor to transfer \$10,500 from the General Fund to the Police Car Reserve Account representing the 2018 allocation and to transfer the remaining surplus, not to exceed \$200,000, after completion of the 2018 Annual Audit to the Public Works Reserve Account.

# **ZONING OFFICER**

Vikki Trost reported that there was one (1) Zoning Permit application approved in January.

### SEWER ADMINISTRATOR

Reid Heinrichs reported the he submitted a monthly update to PA DEP on the status of the failed on-lot system at 2800 Quarry Road. The Sewer Committee hopes to move forward with a small flow treatment facility at the property.

The Digester Project is 85% complete.

Both pumps at the Fetters Mill Pump Station were down during the month and the diesel-powered Godwin pump was able to keep the pump station operating. One of the electric pumps was replaced and is running smoothly. The second pump was repaired and reinstalled and is also running well.

The Equalization Project is 98% complete.

Sewer Committee Chairman Glenn Gurney reported that it has been difficult for the sewer employees to share the 2012 GMC Pickup Truck with the Public Works Department. The Sewer Department recently acquired a used two-wheel drive pickup truck with the help of Mark Pennink and Ric Asplundh, which is all that the employees need. Mr. Gurney expressed thanks to Mr. Pennink and Mr. Asplundh. Mr. Pennink noted that it is helpful for the Public Works Department to use the GMC Pickup during the summer.
